Information on virtual attendance of EGM

The Extraordinary General Meeting (**EGM**) of Multitude SE (**Company**) will be held on 21 March 2024 at 10:00 a.m. (EET / Finnish time).

Shareholders will be able to attend the meeting virtually via an online platform accessible after registration. The meeting will be held as a virtual meeting under the laws and regulations as applicable at the time of the meeting.

Shareholders and persons entitled to vote at the meeting who have registered for virtual attendance and who want to virtually participate in this meeting need to take into account the following procedural aspects with regards to access, electronic voting / questions and the technical infrastructure. The Company explicitly informs them that virtual participation in an EGM is relatively new and that specific technological requirements are applicable. The Company shall make every effort to ensure that shareholders can make use of the best systems currently available on the market, however, the Company cannot guarantee that shareholders nevertheless experience problems in connection with, and/or a result of those technological requirements.

- Shareholders who have registered for the EGM as instructed in the notice convening the EGM, will receive an email with a personal link for attendance. Further instructions for logging in to the meeting will be send in the email prior to the meeting.
- 2. To access the online platform for the EGM, a confirmation with the login details is directly provided by Computershare to the registered shareholders.
- Via the online platform, attending shareholders will be able to vote electronically with their smartphone, tablet, laptop or computer. Participants will be able to speak via the online platform, therefore it is important to have a working headset and webcam.
- 4. Registered shareholders can log into the online platform of the EGM 21 March 2024 at 9:00 a.m. (EET /Finnish time).
- 5. A shareholder who has logged out during the meeting can only re-enter the meeting if they were already duly registered and provided with access rights prior to the meeting. The names of the shareholders who attend the meeting via the online platform will be placed on the registration list.
- 6. At the request of a shareholder, the Company will provide a confirmation of valid registration and overview of the votes cast by that shareholder at the meeting. If there will be a vote, the results of such vote will be available on the Company's website within two weeks of the EGM at the latest. When publishing the voting results, the Company will also state, to the best of its knowledge, if any failures or problems occurred in the technical infrastructure or information security for the meeting.
- 7. Shareholders should be aware that there are certain risks associated with the technical infrastructure used for the virtual meeting. These risks relate to, among other things: any form of malfunction in the equipment used for virtual meetings, software, network infrastructure, servers, internet or telephone connections, video or speech equipment, whether or not caused by an incident in information security (including unauthorized use, a hack, a denial of services attack, a refusal of entry, any type of malfunction or intrusion

resulting from theft or unlawful interception of a password or network access code and any other type of cyber-attack) or caused by a technical failure, such as a power outage during the meeting.

- 8. A disruption or failure in the technology can occur on the side the of the Company, Computershare (and the sub-provider), as well as the shareholder. Any aforementioned risk that materialises, or any other circumstance which could prevent or limit the participation of the shareholder, will in any case remain the sole risk of the relevant shareholder, without the Company becoming liable for any consequences. If a shareholder wants to avoid such risks, the shareholder must consider not to attend the EGM virtually, but to either submit a proxy with voting instructions before the meeting or to vote in advance.
- 9. Shareholders who attend the meeting will be alerted of any disruption or failure in the technical infrastructure that occurs during the meeting, as far as known by the chairman, in case it has a material impact on the rest of the meeting. In such a case, the chairman may decide, as set out in the Finnish Companies Act, to suspend the meeting and continue it at a later stage.
- 10. If the chairman decides to suspend the meeting as referred to in clause 9, the Company will continue the meeting as soon as reasonably practical. The agenda for this meeting contains in in any case, the same agenda items, insofar as these items have not yet been discussed and voted for in the original meeting.

Q: How can I register to participate as a virtual shareholder at the EGM?

A: As a shareholder, you will first need to register for the meeting as set out in the notice of meeting under 3.1.

Q: Where can I login to participate in the EGM as a virtual shareholder?

A: Once you have registered, you will receive a personal email with the login link.

Q: Why do I need to login via the Computershare platform and not via a Multitude website?

A: Due to the confirmation of the shares and the online meeting platform, Computershare will provide and take care of the online meeting platform and personal invitations.

Q: I registered myself to attend the EGM, can I also submit a proxy form in case I can't attend the meeting personally?

A: Changing your attendance is possible until the close of registration, 18 March 2024 at 4:00 p.m. (EET / Finnish time). After the registration deadline you can't change your attendance.

Q: As of which moment can I login to the EGM?

A: You can login within a time frame of one hour before the start of the EGM.

Q: Can I follow/participate the EGM if I'm not a shareholder?

A: No, to attend the EGM a registration needs to be submitted by the company as set out in the notice of meeting under 3.1.

Q: I have already voted in advance, can I change my vote during the EGM?

A: Yes, if you are present in the EGM, you will be able to change your vote.

Q: I don't have a smartphone, tablet or pc. Will I be able to participate the EGM?

A: Unfortunately, in that case you can't join the EGM.

Q: My internet connection isn't working properly. Will I be able to participate the EGM?

A: You will need a working internet connection during the meeting. On your phone you can also use a mobile (3G/4G) signal if available or use WiFi. The shareholder is responsible for a properly functioning and charged device.

Q: Which device should I use to participate online at the EGM?

A: You can participate at the EGM with any device that has a working internet connection and successfully logged in to the virtual environment. Please make sure to have installed the latest version of your internet browser, Chrome, Firefox and Safari.
